2. COMPOSITION/ INGREDIENTS

Ingredients: Water, brown coal, dilute alkali
Proportion 100%

3. HAZARDS IDENTIFICATION

Safety phrases: Keep out of reach of children
Hazard category: There have been no reports in the literature of health effects in workers arising from long term exposure to this substance.

4. FIRST AID MEASURES

Inhalation: Mild irritant. Can only occur when spraying a diluted solution as not a volatile liquid. If inhaled, glow out and seek medical attention.
Ingestion: Small quantities are not harmful; rinse mouth with fresh water. Give a glass of water to drink and seek medical attention if larger quantities consumed.
Eye: Mild irritation, similar to soap. Irrigate immediately with water or neutral saline solution.
Skin: Mild irritant, slippery feel, similar to soap. Wash off with water immediately.
First Aid Facilities: Normal washroom facility.
Advice to Doctor: Treat symptomatically.
